### **Dates Activities**

#### **NOMINATIONS**

Monday, January 4, 2010 to Friday, September 10, 2010  
Nominations may be filed by candidates in the Office of the Clerk during regular business hours, and on Nomination Day, September 10, 2010 from 9:00 a.m. to 2:00 p.m.

#### **CAMPAIGN PERIOD**

Tuesday, January 4, 2010 to Friday, December 31, 2010  
Campaign Period begins on January 4, 2010 or whenever a candidate files nomination papers, and ends on December 31, 2010.

#### **ENUMERATION**

May and June, 2010  
Enumeration will be conducted by the Municipal Property Assessment Corporation.

#### **POSTING OF VOTERS' LIST**

September 2010 (TBD) to Monday, October 25, 2010  
A copy of the List will be available for public viewing at the Township of Stone Mills Municipal Office, 4504 Centreville Ontario.

#### **REVISION TO THE VOTERS' LIST**

September 2010 (TBA) to Monday, October 25, 2010  
If your name was left off the List or is incorrectly entered on the List, you may make application with the Clerk to add or correct.

#### **REVISION – REMOVAL OF ANOTHER PERSON'S NAME FROM THE VOTERS' LIST**

Tuesday, September 7, 2010 to Friday, September 10, 2010  
An elector may make application to remove an elector's name from the Voters' List who is not qualified to be on the List.

#### **NOMINATION DAY**

Friday, September 10, 2010  
Last day for filing nominations. Nominations may be filed between the hours of 9:00 a.m. and 2:00 p.m.

#### **WITHDRAWAL OF NOMINATIONS**

Friday, September 10, 2010  
A nomination may be withdrawn before 2:00 p.m.

#### **CERTIFICATION OF NOMINATION PAPERS**

Monday, September 13, 2010  
The Clerk is to certify nomination papers before 4:00 p.m.

#### **ACCLAMATION**

Monday, September 13, 2010  
The Clerk shall after 4:00 p.m. declare eligible candidate(s) elected by acclamation

**PROXY VOTING CERTIFICATE**

Monday, September 13, 2010 to Monday, October 25, 2010

A person appointed as a proxy must apply for their proxy voting certificate in the Office of the Clerk during normal working hours 8:30 a.m. to 4:30 p.m. Monday to Friday, and on Advance Voting Days from 8:30 a.m. to 5:00 p.m.

Monday, October 25, 2010

Voting hours will be from 10:00 a.m. to 8:00 p.m.
