PROJECT OVERVIEW

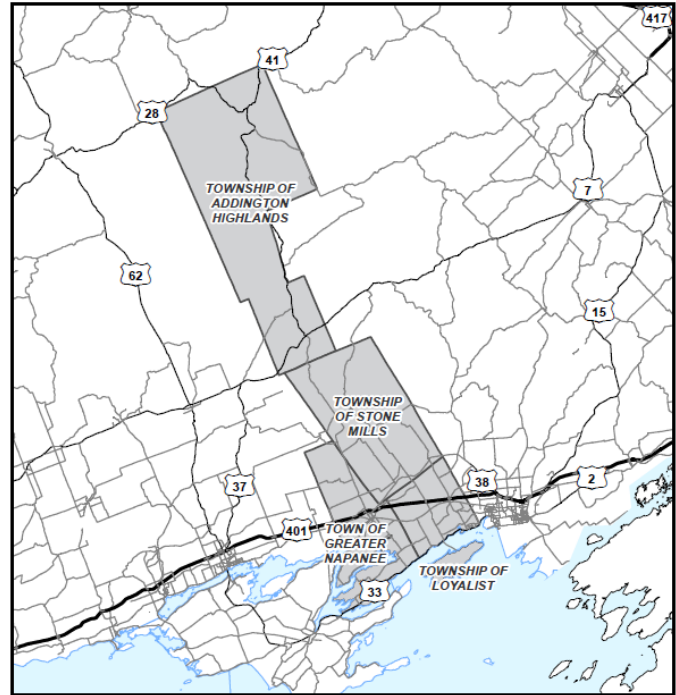
The County of Lennox and Addington (County) is undertaking a review and update of the 2014 Transportation Master Plan. This master plan will be a long-range plan to guide transportation planning and infrastructure needs to accommodate growth and development within Lennox and Addington for the next 20 years.

The Transportation Master Plan will consider:

- Current and future transportation network issues
- Capital project needs
- Road safety and speed management
- Site-specific traffic study needs
- Active travel

MUNICIPAL CLASS EA PROCESS

The study is being conducted in accordance with the requirements of Master Plan Approach #1 of the *Municipal Class Environmental Assessment* (October 2000, amended in 2007, 2011 and 2015), which is an approved process under the *Environmental Assessment Act*. This approach involves the preparation of a Master Plan document after Phases 1 and 2 of the Municipal Class *Environmental Assessment* process.
