




# TOWNSHIP OF STONE MILLS

## Council Recap



### Regular Meeting of Council for January 12, 2026

#### Items for Consideration

##### **Request to Rescind Resolution 30-700-2025**

Reeve Wise received support to rescind the December 8, 2025 Council Resolution 30-700-2025 which directed him to submit a nomination to the Ministry of Preparedness and Response's "Exemplary Service Award" nominating Township of Stone Mills Volunteer Firefighters. Upon review of the application, categories and discussion with the Fire Chief and Deputy Chief, it was agreed that the volunteer firefighters as a group did not qualify for the award/categories to receive the award.

##### **2026 Interim Property Tax Billing**

Council received a Staff Report re: [2026 Interim Property Tax Billing](#) and passed a By-law to enable the municipality to levy interim tax bills to taxpayers.

##### **2026 Temporary Property Tax Billing**

Council received the Staff Report re: [2026 Temporary Borrowing By-Law](#), and passed a By-law to approve temporary borrowing measures.

##### **Amendments to Fees and Charges By-law**

Staff identified various fees within the Recreation and Facilities department that require adjustment as well as introducing some new fees for Council's consideration at the December 8, 2025 meeting. Council members discussed the proposed fees and requested changes that were incorporated into the By-law, which was approved at the January 12, 2026 meeting; these changes to fees take effect **January 13, 2026**. ##### **Pre-Budget Approval Request for Records Clerk Position**

Staff presented a [Report](#) requesting pre-budget approval to bring back the contracted part-time Records Clerk for 2026. This position was approved in 2024 and 2025 and has assisted the organization with managing historical paper records. Staff highlighted in the report that due to elections and staffing issues, it was desirable to bring the contracted employee back for another year. Council received the report and approved the request.
