Items for Consideration



Final Draft of Renovation Plans for Yarker Riverside Park

The final plans for the renovations of Yarker Riverside Park, designed after a public consultation period by Bombus Ecoscapes, were presented to the Council. Staff were directed to proceed with tender preparations, forward plans to the Joint Accessibility Committee for review and incorporate the estimated project costs of \$200,000 into the 2026 draft budget. It was also requested that a toddler friendly play structure be incorporated into the design. [Staff Report](#)

Special Event Permit Application Exemption Request - Newburgh Canal Bash

The Newburgh Volunteer Firefighters Association is set to host its 31st annual "Canal Bash" in Newburgh on February 14, 2026. The event organizers have requested an exemption from the Special Event Permit Application. Council granted a partial exemption, with the stipulation that an Emergency Plan and Site Plan must still be submitted. Council further agreed to cover the \$100 application fee from the Council donation budget. [Staff Report](#)

Update to Township of Stone Mills Health and Safety Policy

In 2025, Staff enlisted the help of Citation Canada, a provider of Human Resources software, to conduct a thorough assessment of the Township's existing health and safety policies. As a result of this review, a new policy was crafted to ensure that the Township's current work practices align with all relevant legislation regarding occupational health and safety. Subsequently, a By-law was passed by the Council to adopt the new Health Policy Manual. [Staff Report](#)

2026 Compensation Report

Council received a and approved [Staff Report](#) recommending a 3% economic increase to the salary structure for staff. This request aims to maintain competitive wages while being fiscally responsible based on current economic indicators.
